Knox County Compost Facility Key Application for Businesses

The key holder agrees to the following terms:

- A one-time fee of \$100 for the first key; \$25 for each additional keys.
- Keys are not to be duplicated or loaned out.
- No mechanical equipment is permitted to load or unload material.
- Report any illegal dumping to the Knox County Commissioner's Office.
- No smoking on the premises.
- The facility gates are to be locked once you have left the premises.
